TERMS AND CONDITIONS

1. Instructions on how to enter and the offer forms part of these Terms and Conditions. This Promotion is not valid in conjunction with any other offer (to the extent permitted by law).
2. Entries are only open to New Zealand residents aged eighteen (18) years or over currently living in New Zealand. Employees and their immediate families of the Promoter, participating retailers and agencies associated with this Promotion are ineligible to enter. 5. The promotion commences on **1st October 2026** and ends for purchases made at close of business **11th January 2027** ("Purchase Period").
6. Entries must be received no later than 11.59pm (New Zealand Daylight Time (NZDT)) on **25th January 2027**.
7. Successful and valid entries who purchase an Eligible Product will go in the draw to win 1 of 5 Luxury Escape Gift Cards, valued at NZ\$5,000.00 each. Details on how to redeem the Gift Card via travel company Luxury Escapes will be sent to each winner. Gift Cards are subject to Luxury Escapes' standard terms and conditions, including any expiry dates and booking restrictions. Total prize pool is NZ\$25,000.00.

 - a) purchase an Eligible Product during the Purchase Period from a participating retail store in New Zealand (in accordance with clauses 3 and 4 above) and retain the original packaging and proof of purchase receipt;
